## Intersession / Summer School 2024 - TENTATIVE

Registration for our Summer session courses begins on March 6, 2024, at 12:30pm.

Note that we are again offering courses in a May intersession period that will follow exams and precede graduation. This opportunity, open for credit to rising 2L and 3L students as well as continuing MLS / LLM students, involves a limited number of intensively-taught, single-credit courses that are described further below. **Note that intersession courses require the effort of a full-time job for the week, so you may only enroll for one course per week.**

We are also still offering a menu of summer courses over two longer sessions, one from mid-May through early July, and another from mid-July through mid-August. Note that there is a mix of remote and in-person classes, but in-person classes will NOT have a remote option (i.e., **no hybrid classes**). Also **any remote courses this summer will count as Distance Education under ABA standards**, and students are limited to taking no more than 1/2 of their total credits for graduation via Distance Education. (Note: Remote courses before Summer 2022 do not count against that limit. You can check your total distance credits by reviewing the “Remote Coursework” section of your degree audit in SAGE. This shouldn’t go over 30 credits.)

Registration for all summer classes - both Intersession and Regular Summer Session courses –will take place through SAGE. For financial aid reasons, students can only put themselves on a waitlist for Summer Session 2 courses until May 20th. After May 20th students on the waitlist will be registered for the class. Note that for certain courses, enrollment is first come first served. Students may only register for one Intersession class in a given week; for the regular summer session, students are allowed to register for up to 7 credit hours (per session) of regularly scheduled summer school courses, with the exception of Externship. You must enroll in 3 credit hours over the summer to qualify for financial aid for the summer semester. If you want to receive financial aid for the summer semester, you must contact the financial aid office; we’ll send more information about this in the next few days.

**TO REGISTER STARTING MARCH 6<sup>th</sup> at 12:30pm – 1) Log into SAGE. 2) Once registration opens, select “Register and Drop Sections.” 3) Tuition charges are per credit, and will appear on a student's account at the time of registration. Financial Aid for Intersessions and Summer Session 1 will be disbursed on May 20; tuition should be paid no later than this date. Note that scholarships are not applicable to Intersession / Summer Sessions.**

**>>A special note about externships:** The number of credits awarded depends on the number of hours to be worked at the field placement. Please consult with Professor Wright prior to the beginning of the first session of summer school regarding the appropriate number of credits for which to enroll. Students registered in 3-6 credits of Externship can also take a course in both of the summer sessions. Students registered for 7 or more credits of Externship must get approval from Dean Mac Alpine or Dean Dobbins to add any additional summer courses. Also, although the field placement may run throughout the entire summer (i.e., across both session one and session two), you must enroll in those courses for session one but need not reenroll for session two.

**>>>International Law Practicum w/ Prof. Buske in Tanzania:** As an accompaniment to her International Children’s Rights Intersession Course, Professor Buske offers a two-credit course that involves a one-month overseas trip to Tanzania. Students will pay their own travel costs, and will need to enroll in the course in order to receive credit for their work. This course is not available to graduating students studying for the bar. **Interested students should contact Prof. Buske.** Note that this course, like externship, runs throughout the entire summer, so you need not enroll for session two.
